Mayor's Message

By now, most of us have been impacted in some way by the slowdown in our country's economy. We've seen a large impact here in our own town, with new construction coming to a sudden, screeching stop. Last year at this time, the city had issued 36 building permits for new construction – so far this year; the city has issued only 7. That's good news for those who want to keep our city small and rural, but bad news for the contractors, framers, masons, excavators, and others connected with the building trade. Unfortunately, many residents of our town are struggling because of this slowdown.

Still, our area is growing. In 2007, Utah County grew by 10,000 residents, which is equivalent to adding an entire new city to the county in just one year, one that is one and a half times the size of Mapleton. At the same time, Salt Lake County surpassed one million people, and Utah County reached a population of half a million.

State demographers have revised their population predictions, estimating that by 2030, Utah County's population will have doubled and be approaching one million people (907,000.) And, it is estimated that by 2035, our county will have exceeded the million person mark.

Until the economy picks up and new construction resumes, there is no telling what Mapleton will look like in a few years. We expect growth will resume soon, and are taking steps to prepare for that growth. Many of you by now are familiar with the proposed irrigation pond, which will help us meet our water needs for the foreseeable future. We are actively pursuing several commercial possibilities, and taking steps to protect our financial situation. We are also taking steps to address our sewer, public safety, and other infrastructure needs. Although upgrades to those facilities cost money, it becomes increasingly clear the cost of doing nothing will be greater.

The slowdown in the economy creates opportunities for us to step back and evaluate, and in some cases, upgrade our resources at reduced costs. But the slowdown also has a large impact on our city's finances and on many of our residents personally. Knowing some of you are in difficulty is distressing to us, and we hope the difficulties you are experiencing are very short lived. For our part, please be assured that we at the city are doing all we can to minimize the negative citywide impacts, while capitalizing on the positive ones.

City Wide Pressurized Irrigation Water Service

Two public meetings were held last month to outline this project and its wide ranging implications. With the benefit of concerns and support expressed at those meetings the City Council has agreed to proceed with the project to expand the pressurized irrigation water service throughout the entire city.

Phase I of the project (\$5 million) will include the complete refurbishment of the disused pond located behind Maple Street, Aspen Grove and Dogwood Drive, which the city purchased from Mapleton Irrigation Company last summer. The reservoir will be of sufficient capacity to deliver pressurized irrigation water to all Mapleton residents, after 2010, following the pressurization of the Mapleton Lateral pipeline. The city has decided that all existing and future users of the pressurized water system will be required to pay according to metered usage and everyone will be assessed according to the measured volume of water.

This will apply to the four hundred homes located in the north west of the city whereby unlimited quantities of water are currently provided for a flat rate of \$17 monthly charge. The City will pay for meters to be installed next year. Bids for this project are being invited and construction work on the irrigation reservoir is anticipated for completion by the fall of 2008. Meter installation should be completed by the spring of 2009. For further detailed information about this impending change, you may call Scott Bird, Public Works Operations Director, at 489-6253.

Rabies and Licensing Clinic

On April 12th from 10am-12pm Mapleton City will be hosting a rabies and dog licensing clinic behind City Hall in the south parking lot. The rabies shot will cost \$10; and the dog licensing will be \$10 a year for up to three years until your dog's rabies shot expires. If your dog is not spayed or neutered the cost will be \$25 per year. The veterinarian will also have other shots for dogs such as \$10 for distemper, adenovirus-type 2, parainfluenza and parvo virus. For cats there will be Feline Viral Rhinotracheitis, calici virus and panleukopenia for \$10. Please make sure that ALL DOGS are on a leash, and that cats are in a crate, box or carrier. If you are paying by check you will need to make two checks out, one for the dog licensing, and one for whatever other shots your animal is getting. Painting Class

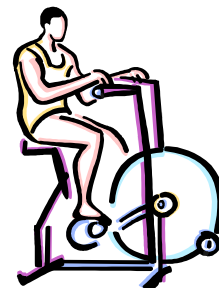

2007 Annual Drinking Water Quality Report

Mapleton City

We're pleased to present to you this year's Annual Drinking Water Quality Report. This report is designed to inform you about the quality of the water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water. Our water sources have been determined to be from groundwater sources. Our water source is the Right Hand Fork Springs, Dunham Spring, Service Berry Springs, Seal Well, Carnesecca Well and Westwood Well.

The Drinking Water Source Protection Plan for Mapleton is available for your review. It contains information about source protection zones, potential contamination sources and management strategies to protect our drinking water. Our sources have been determined to have a low level of susceptibility from potential contamination from sources such as septic tanks. We have also developed management strategies to further protect our sources from contamination. Please contact us if you have questions or concerns about our source protection plan.

There are many connections to our water distribution system. When connections are properly installed and maintained, the concerns are very minimal. However, unapproved and improper piping changes or connections can adversely affect not only the availability, but also the quality of the water. A cross connection may let polluted water or even chemicals mingle into the water supply system when not properly protected. This not only compromises the water quality but can also affect your health. So, what can you do? Do not make or allow improper connections at your homes. Even that unprotected garden hose lying in the puddle next to the driveway is a cross connection. The unprotected lawn sprinkler system after you have fertilized or sprayed is also a cross connection. When the cross connection is allowed to exist at your home it will affect you and your family first. If you'd like to learn more about helping to protect the quality of our water, call us for further information about ways you can help.

I'm pleased to report that our drinking water meets federal and state requirements.

If you have any questions about this report or concerning your water utility, please contact Scott Bird at 801-489-6253. We want our valued customers to be informed about their water utility. If you want to learn more, please attend any of our regularly scheduled meetings. They are held on the first and third Wednesdays at 7:00 pm at the city offices.

Mapleton City routinely monitors for constituents in our drinking water in accordance with the Federal and Utah State laws. The following table shows the results of our monitoring for the period of January 1st to December 31st, 2007. All drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In the following table you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Non-Detects (ND) - laboratory analysis indicates that the constituent is not present.

ND/Low - High - For water systems that have multiple sources of water, the Utah Division of Drinking Water has given water systems the option of listing the test results of the constituents in one table, instead of multiple tables. To accomplish this, the lowest and highest values detected in the multiple sources are recorded in the same space in the report table.

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter (ug/l) - one part per billion corresponds to one minute in 2,000

years, or a single penny in \$10,000,000.

Parts per trillion (ppt) or Nanograms per liter (nanograms/l) - one part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000.

Picocuries per liter (pCi/L) - picocuries per liter is a measure of the radioactivity in water.

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level (MCL) - The “Maximum Allowed” (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The “Goal”(MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Date- Because of required sampling time frames i.e. yearly, 3 years, 4 years and 6 years, sampling dates may seem out-dated.

Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant you should ask advice from your health care provider.

As you can see by the table, our system had no violations. We're proud that your drinking water meets or exceeds all Federal and State requirements. We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water IS SAFE at these levels.

All sources of drinking water are subject to potential contamination by constituents that are naturally occurring or man made. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline at 1-800-426-4791.

MCLs are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

As a precaution we always notify physicians and health care providers in this area if there is ever a higher than normal level of nitrates in the water supply

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

We at Mapleton City work around the clock to provide top quality water to every tap. We ask that all our customers help us protect our water sources, which are the heart of our community, our way of life and our children's future.
