# Mayor's Message

#### All Citizens: Now is the Time to Get Involved!

Back in January, I discussed briefly the process the City was going to follow as we gathered the information needed on the proposed EBCo boundary line adjustment project. The City Council, Planning Commission, Economic Development Commission, and many key City Staff members, have participated in many meetings and public workshops sessions and have more planned.

We anticipate there will be three key steps to the process and within each step of the process you, a citizen of Mapleton, will have an opportunity to become educated, ask questions and become informed. The <u>first step</u> will be two State reports on the remediation of the soils on the Ensign Bickford property and a Site Management Plan. The <u>second step</u> will be a study done by an independent contractor on the impact to the city, and the <u>third step</u> will be the developer's concept plan, and the landowner's application for the adjustment to Mapleton's southern most boundary.

#### STEP ONE is here

The State of Utah's Division of Solid and Hazardous Waste is soliciting public comments on the April 2010 revised draft Site Management Plan (SMP) and the draft Environmental Covenant for The Ensign-Bickford Company (EBCo) site located near the mouth of Spanish Fork Canyon at the junction of Highways 6 and 89, Spanish Fork, Utah.

The draft Site Management Plan includes details on the long-term management controls, and activity and use limitations for the areas where residual contamination will remain after extensive site remediation. The draft Environmental Covenant will obligate EBCo and any successors to comply with the activity and use limitations for the areas where residual contamination will remain.

The public comment period for the draft SMP and Environmental Covenant will commence on Thursday, May 6, 2010.

**During this public comment period, two public information meetings will be held as follows:** May 12, 2010, 7:00-9:00 pm and May 13, 2010, 6:00-8:00 pm in the Mapleton City Hall Community Center.

In addition, a public hearing will be held on June 2, 2010, 6:00-7:00 pm in the Mapleton City Hall, Council Chambers, facilitated by the State of Utah

#### **Public Works**

It is that time of year again to start watering lawns and landscaping! It has been brought to our attention that there are a few residents that have hooked on to the Pressurized Irrigation system without paying a connection fee or having it inspected. This is in violation of Mapleton City Code, and offenders will be prosecuted. The Public Works Department is checking on a regular basis to make sure that all connections are paid for and connected correctly. Also, connection to a secondary water source (pressurized irrigation) requires a physical air gap, not just a valve between the secondary and culinary systems. Please be aware that a cross connection between the pressurized irrigation system and the culinary water system is in violation of State and Municipal Code. This is to protect our culinary system from contamination. If you have any questions on your connection please contact Public Works at 801-489-6253.

### Plan Ahead for I-15 Delays



#### Plan Ahead Now for Significant Delays on I-15

In the coming months, drivers on I-15 should anticipate longer travel times through UDOT's Utah County I-15 Corridor Expansion Project (I-15 CORE), which adds two additional freeway lanes in each direction from Lehi to Spanish Fork and extends the Express Lane from University Parkway to Spanish Fork. The project also rebuilds or restores 55 bridges and replaces or modifies 10 interchanges, including a redesign of the U.S. 6 and Spanish Fork Main Street interchanges – combining them into one.

From May to October, Mapleton residents traveling southbound I-15 could experience a one- to two-hour delay in the Provo s-curve area between Orem University Parkway and Provo Center Street. Delays could be up to six hours during holiday weekends and local traffic will be slowed as east-west signal timing is adjusted to support a greater number of cars on north-south alternate routes. These projected delay times are if the current number of cars continues travel during those peak commute times.

UDOT encourages drivers to TravelWise by telecommuting, shifting travel times, alternating work schedules, carpooling and using local roads for shorter trips to avoid delays. Drivers can stay informed by signing up for weekly e-mail updates at udot.utah.gov/i15core, texting "i15" to 83043, joining the project's Facebook page, Facebook.com/i15core, and following the CORE Twitter at Twitter.com/i15core.
