GENERAL PURPOSE:

Under the supervision and direction of Sergeants and the Chief of Police, the patrol officer is responsible for all general uniform police operations. Those operations include the following but are not limited to: patrolling Mapleton City to interdict any criminal activity, render aid, arrest or cite when appropriate, animal control, responding to medical calls and protect and promote public peace. The police officer will be the initial investigator in allegations of criminal activity and will be responsible for the prompt and proper preliminary investigation of the incident. The police officer is generally the first representative of the city government at any public safety incident; and as such should be well trained, competent, and professional in the performance of their duties. The police officer will be expected to provide a courteous, professional, and competent law enforcement product to our community which they serve. Mapleton City Police Department is committed to Community-Oriented Policing and determined to provide a high level of service to all citizens.

Qualifications:

Applicants must be 21 years of age or older at the time of employment. Applicants must possess a valid Utah state driver's license or have the ability to obtain one prior to employment. Applicants should be able to demonstrate knowledge of community oriented policing, patrol operations, criminal investigations, animal control, court security, report writing, officer safety, and safety standards related to the use of vehicles, firearms, and other specialized police equipment, among other duties and responsibilities as directed.

Testing Process:

Testing may include but is not limited to the following:
Physical fitness test. Written Exam, Practical Exercise, Oral Board Interview, Criminal Background Investigation, Polygraph, Sergeant Interview, Chief of Police Interview.
