## Regulations for the Control and Protection of Mapleton City Rights-of-Way

No person, firm or corporation shall be permitted to build, construct, or install on any Mapleton City right-of-way, any street paving, sidewalk, curb and gutter, or any other facility, thing, or appurtenance not heretofore permitted by law, without first obtaining written permission from Mapleton City authorities having jurisdiction over such rights-of-way.

The provisions of any permit granted shall be construed as regulatory and not as contractual. No interest or right of an applicant shall be transferred to another except by written consent of the Mapleton City Public Works Superintendent. No inherent or restrained right or privilege belonging to any abutting property owner is affected or interfered with, nor is Mapleton City Corporation or any Mapleton City authority to be held responsible for any damage claim which may arise between the applicant and any property owner concerning said right-of-way or its occupancy or use.

Before a permit is issued, plans and cut sheets, if applicable, shall be furnished to Mapleton City Street Public Works Superintendent with such copies of the working drawings as may be required for approval and construction purposes. Where engineering is desired by Mapleton City, the applicant, firm, or corporation signing the permit shall pay all engineering fees.

Applicant or applicant representatives shall inform the Mapleton City Public Works Superintendent or his representative one (1) work day before work is to begin. All materials and each part or detail of the work shall be subject at all times to inspection by the Mapleton City Public Works Superintendent or his authorized representatives. Applicant or his firm or corporation shall be required to pay reasonable inspection fees.

Applicant agrees that all construction shall conform with Mapleton City Standard Specifications (copies of specifications are available at Mapleton City Planning & Zoning Office). Applicant is responsible for work zone safety and traffic control and shall comply with all applicable laws and regulations of any public body having jurisdiction for safety of persons or property or to protect them from damage, injury or loss; and shall erect and maintain all necessary safeguards for such safety and protection.

## **Permit Requirements:**

- 1. Copy of a valid State Contractor's License (must be valid for excavation);
- 2. Copy of Liability Insurance Certificate (\$1 million minimum); and,
- 3. \$10,000.00 or greater (depending on valuation of project) completion and restoration bond.
- 4. Copy of Certificate of Workers Comp Insurance.
- 5. All fees paid to the city.
